I also understand that the terms and condition of my membership may be changed, with or without cause, with or without notice, at any time by the PFD. I understand that no PFD representative, other than it's president, and then only when in writing and signed by the president, has any authority to enter into any agreement for membership for any specific period of time, or to make any agreement contrary to the foregoing.
