She also thanks Public Works for working so hard on getting mulch and completing the placement. Applegate also shared the new park equipment that they are looking at replacing.

Community Visioning – Wolfe shared there will be displays of the concept designs at SummerFest in the morning at Boll's and in the afternoon at Woomert Park.

Water and Sewer – McDonough shared there was a site visit on 7/7/21, Frank with Iowa American Water was able to see the infrastructure to help move the soft proposal along, the city should expect to receive the soft proposal in 6-8 weeks. McDonough also discussed the water main break and sewer back up and wanted to create a plan for future issues.
